Other source material used herein includes photostatic copies taken from pension files; other data has been taken from abstracts of deeds which are on file in the Office of the Register of Deeds of Rowan County, North Carolina by William D. Kizziah, professional genealogist of Salisbury, North Carolina.

When actual dates of births, or deaths, or marriages were not available from the above source material then they were determined from the United States Census reports as more fully shown and described in the said application and its attached exhibits.

D. one thousand nine hundred and nine, personally appeared before me, a Clerk District Court within and for the County and State aforesaid, DANIEL PRUITT, who being duly sworn according to law, declares that he is 75 years of age, a resident of CLARINDA, county of PAGE, State of IOWA; and that he is the idential person who has enrolled at Chicago, Ill. under the name of DANIEL PRUITT, on the 25th day of August, 1861, as a private, in Company G. 42nd Illinois Infantry, in the service of the United States, in the Civil War, and was Honorably Discharged at Atlanta, Ga., on the 16th day of September, 1864.

That he was not employed in the military or naval service of the United States otherwise than as stated above. That his personal description at enlistment was as follows: Height, 5 feet 6 inches; complexion, light; color of eyes, grey; color of hair, brown; that his occupation was Farmer; that he was born September 7, 1834 at Tippecanoe Co., Indiana.

Taken from an original letter "Biography and Personal History of Rev. Alonzo Pruitt". This letter is from A. Pruitt, Smithland, Iowa to Mrs. Will Widney, Shenandoah, Iowa 606 S. Center St., mailed Feb. 25, 1942.

I was born in the little town of Milford, Ill., Iroquois County, June 22, 1858 of hardy pioneer stock. My grandfather John R. Pruitt was born in Virginia on July 5, 1804. Moved with the family to Kentucky. Here he grew to manhood. In 1820, moved to Indiana, Washington Co., seven years later to Tippecanoe county near now LaFayette. It wasnot yet founded. In 1825, he was united in marriage to Miss Barbara Beeker. It was near the Battleground of Tippecanoe and Tyter where most of the family were born. In 1856 with his family he came to Milford, Ill., Just a trading post and engaged in the mercantile business until his death May 1, 1858. To this union were born 7 boys and 4 girls. Lucretia, Simeon, James A., Daniel, William Henry Harrison, John B., Joseph, Randolph, Elizabeth, Jane, and Margaret.

My Grandmother, Barbara Beeker, born in North Carolina, Oct. 17, 1809. Her grandfather served as a soldier under General George

Washington in the Revolutionary War. One brother Lem Beeker served under General Tyler in the battle of Tippecanoe, Indiana.

Daniel Pruitt, sone of John R. and Barbara (Beeker) Pruitt born September 7, 1834. Daniel was my father. In the winter of 1872, at a Methodist revival held at the Harness school house 2 miles south of Milford, Illinois, was converted and became a powerful minister of the gospel of the old school and Theological type.

My mother, Sarah Ann (Willson) Pruitt, born in Ohio, February 15, 1837 daughter of Eliza (Tatman) and John Wilson, her husband. Sarah Ann®s father was killed in Ohio in the summer of 1840. While he was working in the field by the Indians. Daniel Pruitt and Sarah Ann Wilson were joined in marriage September 17, 1857.

To this union were born 3 boys and 1 girl as follows: Alonzo; Viola; J. B. McPherson and Edward.



12 The following Historical and Biographical Sketch of Aionzo) born in Milford, Illinois June 22, 1858. First school attended was the Mike Harness (usually known as the Pot hound school because of Mr. Harness having so many hounds.) In that day, books were scarce and Alonzo learned his A B C's that was printed on a paddle on account of the hard times at the close of the war and very limited means of his father, Alonzo never got farther than the 8th grade in school. His father was of a roving disposition in his early life. In 1871, was on his way to Mitchell County, Kansas, then a typical western plain buffalo, antelope and Indians plenty. Here he homesteaded. This was a sad move for Alonzo now at his formative period of life the sight of buffalo and antelopes and Indians almost daily he was changed, and he changed with the spirit of the cowboy and the West. In 1872, his father moved back to Milford, Illinois. Here I attended the Milford High School 6 months of the year until February 1878.

When we moved again to Northwest Kansas, here again I was enthused with the old time western spirit and all that went with it. In 1880, I met Miss Josephine E. Renshaw, well educated, well refined, handsome and a lovable character. On September 17th, 1881, we were married in Beloit, Kansas by Rev. Graves, Pastor of the Methodist Church. It was through love and hard work Josie as I called her, gave me daily lessons out of our school books until I was able to teach school in Kansas. And on our coming to Iowa on Thanksgiving Day 1890 landing at Little Sioux, here she continued to teach me until I was able to obtain a first grade certificate. I taught school and farmed until I got my life"s bearing. After the experience of a well grounded faith in the love and power of Jesus Christ and his gospel, on September, 1899 left his farm and entered the ministry, serving Stuart charge in the Council Bluffs district for four years. Was also Mayor of Stuart a In the fall of 1925, Alonzo bought a nice bungalow at 2511 South Cedar St. Morning Side, Sioux City. It was here on Sept. 2,



1927, at the Sioux City Methodist Hospital God kissed the sweet spirit of his wife Josie and took it home to be with him. Alonzo with all efforts together with his happy disposition never was the same afterwards. He began to go down in health.

In March 1931, Alonzo was again married to Mrs. Annis Parker, widow of Will Parker who was killed in the trenches of France of the first World War. Mrs. Parker was a graduate nurse, fine Alto singer, good homemaker and highly respected by all who knew her.

In the marriage of Alonzo and Miss Renshaw there were born the following children: One boy and three girls: Gertrude Elsie,

Dwight L. Daniel, Sarah A. Ralph C. dying in infancy, Bernice Evalyn.

Gertrude Elsie on January 8, 1905 at Ames, Iowa married T. F.

Adams. To this union were born Laurance, dying in infancy, Regenald
G. Mildred, married Harold Entrican, children are Charlott and Marlys.

Lillian, Robert, Regenald and wife have no children, Dwight L. Daniel
on Nov. 14, 1907 married at Mantow, Iowa, Miss Edna Francis Gundar.

She dying Sept. 26, 1923. He then married Miss Nellie Brakel.

There were no children born of either marriage. Sarah Ann at Helena,
Montana on June 12th 1918 married Herbert Grand: to this union were
born twins, Ruth Alice and Herbert Jr. and Elizabeth.

Bernice Evalyn at Onawa, Iowa, June 14, 1924 married Roy B. Carmon. To this union were born two boys Jr. and Jack P. Alonzo is now in his 84th year is like a note past due having lived out his allotted time and now abiding his time and isready to go and be with his Heavenly Father and loved ones.

Mrs. Grace (Widney) Brown states that her mother, Viola (Pruitt) Widney says, "There are errors in this sketch.

John R. Pruitt was born in Kentucky (Indiana census bears this out in that his son Daniel gave his father's birthplace as Kentucky.)

Also marriage license of John R. Pruitt and Barbara
Beeker shows they were married in 1827 instead of 1825.
Also Indiana census states Sarah Wilson was born in
Indiana and not Ohio and her father was not killed by
the Indians, but died when she was three years old of
an old ailment, inflammation of the bowels."

Note: It is the Iroquois Co., Ill. census that list
Sarah Ann Pruitt. Also a brother of Daniel Pruitt
states his father was born in Va. and therefore the
family seem to disagree as to state where John R.
Pruitt was born. John R. Pruitt had financial
reverses and must have moved for have been unable
to find him in 1850 census. His widow Barbara
(Beeker) Pruitt returned to Iroquois Co., Ill. in
1860. TKF.

On this 30th day of July, 1913, at GOODWINE, County of IROQUOIS, State of Illinois before me W. S. Bridges a special examine of the Bureau of Pensions, personally appeared JAMES A. PRUITT, who being by me first duly sworn to answer truly all interrogatories propounded to him during this speical examination of aforesaid claim for pension, deposes and says: I am 80 11/12 of age; my post-office address is Goodwine, I11. JOSEPH PRUITT claimant herein is my brother; he was 70 years of age last March 16th. I was old enough to remember his birth; he was born in Tippecanoe Co., Ind. I was going on 11 years of age when he was born. I have here a record of the names and dates of births of all the children born to my father JOHN R. PRUITT and my mother BARBARA BEEKER PRUITT. My father died May 28, 1858; and this record was made by him in or about 1854 and it has been in my possession ever since. The original record in Family Bible was taken to Kansas by my mother and when she returned here she did not bring it and I presume it was left in the hands of some of the younger children out there. My mother died here in 1896. I do not know whether the original Bible record is in existence.

According to the record I have here the following are the names of dates of births of all the children born to my father and mother.

I do not remember the regiment in which JOSEPH served; he was living over in Indiana when he enlisted and I had no dealings with him to enable me to learn his regiment. JOSEPH claims that he was 70 years old last March 16, and this is sure his age.

I have no interest in this claim. I have heard read this deposition. I have understood your questions. My answers are correctly recorded.

The correction of 10 or 11 on line 7 made. I was going on 11 years old when he was born. If I said 10 it was an oversight. I know I was working at my grandfather's when Joseph was born.

Research has not been completed on the Beeker lineage.

Brothers do not agree on the birthplace of John R. Pruitt, some say Va. and others Ky. Note 1880 census; Daniel lists Ky., James A. lists Va. Possibly born close to Va. line.

At the age of 12 years, he came with his parents to Tippecanoe

County, locating in Tippecanoe Twp. where he still resides, on the

farm purchased by his father at that time. On the 14th day of Feb.

1840, he married Miss Anna Stingly, who bore him 4 children all

of whom are now living, named respectively: Dulcina, Manford,

Norsemus, and Orlena.

Since the death of his father, Mr. Beeker has occupied the farm which located and cleared by the former. He has exerted every energy to improve his farm and render it equal to the best; and in this effort he has been successful.

His political principals were favorable to the Democratic party; but in recent years he has embraced the principles of the Republican party and is now a staunch supporter of that branch of the body politic. He never courted political distinction and never served in a public capacity, desiring no higher distinction than the well-merited reputation of an honest and industrious farmer.

His parents, John and Christina Beeker, were of German descent but both were natives of North Carolina. John Beeker entered the wilderness of Indiana at a very early day, and was engaged as an Indian trader, deriving a handsome profit from his traffic. The sports afforded by a new and unsettled country were fully enjoyed by his son, Leonard, who entered with a boy's delight upon the chase of deer and other wild animals over trackless forests which now stand supplanted by well cultivated farms.

The father, who sold goods to the dusky inhabitants of the county, has long slept the sleep of death and his son, Leonard, then

a boy, is now in the declining years of matured manhood. He has been an appreciative witness of the various stages of improvement through which this county has passed, and has ever been ready to lend a helping hand in projects having the general welfare of the county for their objects.

"I have made a survey of the records pertaining to Jacob Young (usually signed J-U-N-G by said Jacob) but was unable to locate the marriage record of Jacob Young and wife Magdalen or between their daughter Christina and John Beeker."

Item I now refer to a letter to me from Mrs. Winfred A. Brown #1 dated June 5th 1956, from which I take the following data, upon which to base my conclusions, or rather as a guide I might say. She states as follows:

- (a) That her ancestry is established as far back as one Jacob Young, whose will was probated in Indiana in 1823, his wife being named Magdalen, and the following children: Jacob, Frederick, Christina, Elizabeth, Ann Maria, Magdalen.
- (b) Man by name of Jacob Young mentioned by Miss Adelaide Fries in her Moravian History who lived on the Holston. Also a Jacob Young whose name was spelled Y-O-U-N-G in the body of the deeds, but signed J-U-N-G as the Germans usually signed the name.
- (c) That Christina Young, daughter of Jacob Young married John Beeker, in Rowan Co. N. G. They had a daughter Barbara who was born in N.C. in 1809. Deeds are in Indiana as ear; u as 1814 from Jacob Young to John Beeker.
- (d) The said daughter Barbara married John R. Pruitt and they were the grandparents of Mrs. Winfred A. Brown.

"COMMENT: Judging from the above records, and from records found in the Rowan County Archives, at the County Court House and the Rowan Public Library, it appears certain that the above people were in Rowan County as early as 1778 and likely before that date, as will be seen by the evidence that follows in this report."

"PROOF THAT JACOB YOUNG WAS A RESIDENT OF ROWAN CO., N.C. AUGUST 7, 1778.

As Rowan County covered a vast area in 1778, it was not convenient for all of the citizens to travel up to 100 to 125 miles to the Court House to appear before the Court. On August 7, 1778, the following entry appears in the MINUTES OF THE ROWAN COURT OF COMMON PLEAS AND QUARTER SESSIONS:

"August 7, 1778, ORDERED BY THE COURT, That all Persons who have neglected to take the Oath or refused to appear before the respective Justices of the Districts where they may be resident, to take the Oath of Allegiance to the State as required by Law, amd have neglected to appear at this Court & offer Excise for such Neglect or Refusal, and admitted to take said Oath, depart this State within Sixty Days after the Rising of this Court, to the West Indies or Europe, and that the Clerk of this Court Advertise this Order."

On this same date, August 7, 1778, JACOB YOUNG appeared before this Court and takes the Oath of Allegiance, and same is entered in the Minute Book of this Court. Others also appeared, and most of them were loyal citizens who had for various reasons neglected to take the action earlier.

COMMENT (by Wm. D. Kizziah)

Item #3, established the fact that JACOB YOUNG was a resident of Rowan County, N.C. on August 7, 1778, as the Court Order states that the Law requires persons to appear in the Districts where they were resident or appear before the County Court (this Court). This is proof that JACOB YOUNG WAS A RESIDENT as he took the Oath on the same day, Aug. 7, 1778.

The various deed records are proof that he owned and sold land in Rowan County, and since there was not an older man by the name of YOUNG (including the various spellings, in this same area, it appears that Michael may have been Jacob's father, since Michael conveyed land to Jacob. Michael Young (as he later appears in the records) and Younger were the same person, the Germans using various forms of spelling at different times.

Many of the Rowan County families were in the "Holston" Settlement now in Tennessee, and some returned to Rowan. Jacob Young could have been one of these since the Moravian Settlement was in Rowan as Miss Fries states in her History.

I, Jacob Young of Washington County, Indiana Territory, a farmer, considering the mortality of body, and being yet in perfect health and sound memory, I have taken unto consideration how to dispose of my property which may be left after my death.

I therefore make my last will and testament in manner following:

FIRST, I recommend my soul to God who created me, and through his son Jesus Christ received me for his child, my body to earth and that the same after my death shall be buried in Christian like manner if probable.

SECOND, It is my will and testament that all my just debts shall be paid after my death as soon as possible.

THIRDLY, It is my will and testament that MY BELOVED WIFE, then surviving widow MAGDALEEN shall have in her possession and keep all my personal property, so long as she lives, and shall have full power to anyone of the same as she deem proper, and also she is to have the theropart of all that groweth on the place whereon I have every year. If she stands in need of the same for her support.

FOURTHLY, It is my will and testament that MY SON JACOB shall have and own and keep in possession the land whereon I now live, as the same is land off between me and JOHN BEKER on condition that he will give to HIS MOTHER annually one third as above stated. Further he shall give to SOLOMON YOUNG, SON OF FREDERICK one Coult or Horse WHEN HE ARRIVES TO MATURE AGE, and to ANNA MARIA said SOLOMON SISTER a cow when she is of age.



FIFTHLY, It is my will and testament that MY SON FREDERICKS SURVIVING CHILDREN shall have after the death OF MY SURVIVING WIDOW, fifty dollars each, which shall derive from the moveable property, if they do not receive the same before.

SIXTH, It is my will and testament that the property remaining after the death OF MY WIFE shall be equally divided between MY DAUGHTERS ELIZABETH, CHRISTINA, MAGDALEN, and ANNA MARIA on condition that the accounts which Stein charged against them shall be added in, and be divided according to the same, so that they all shall have and equal part.

I shall conclude my last will and testament by appointing MY TWO SONS-IN-LAW, PHILLIP SHUOLTZ and JOHN BEKER, EXECUTORS, so that all shall be done according to this my will and testament, and this shall remain my last will and no other, to which I set my hand and seal the FIFTEENTH DAY OF MAY in the YEAR OF OUR LORD, ONE THOUSAND EIGHT HUNDRED AND SIXTEEN.

" John and Christena Beeker left North Carolina in the year 1805, landing in Washington Co. Grandmother Beeker had three sisters, two brothers, father and mother. They all came north together. There were five families together traveling in wagons. Some on horse-back. Several of Grandfather's people (sister) came at the same time. They were near Martinsburg, that was their nearest town. The oldest child died and was buried there. She was born in North Carolina. The rest of the family with the exception of William and Christena were all born in Washington Co. They then decided to come further north in April in the year 1828. They first went to the Grand Prairie. They began getting the timbers ready to build the log cabin. Then Grandmother went out where grandfather was chopping and she told him she could not live there it made her home-sick. So, he ask her how she would like toat place down on Pretty Prairie as it was for sale, stock and all. So she thought it would be alright. But grandfather heard they were going to run it pretty high, so he knew of a man living at Logansport who was guardian for some children and had money to loan, so grandfather put the saddle and saddle-bags on his horse and went to see him. He came home with the old saddle bags full of money. The sale came off and he did not need the money. So next day he took it back as there were no notes given. His word was as good as a note. Their oldest daughter Barbara Beeker Pruitt was married down there. She was only 17 years when married and she had two children born there. She came north with her parents also. So that was known as the old Beeker homestead for a number of years. "
